**Announcement of Synchrotron Light Research Institute (Public Organization)**  
**Guidelines for Prevention Measure and Surveillance of Coronavirus (2019-nCoV)**  
**(No. 2)**

Regarding the Announcement of Synchrotron Light Research Institute (Public Organization) on Guidelines for Prevention Measure and Surveillance of Coronavirus (2019-nCoV) dated 3 February 2020, the outbreak of COVID-19, formerly known as 2019-nCoV, is still expanding with great number of infections reported in many regions worldwide.

For further disease prevention and control of COVID-19, SLRI, therefore, announces more measures and disease surveillances to prevent possible related effects on health of SLRI staff and their routine responsibilities. With reference to SLRI Regulation on “Working Hours and Official Holidays” B.E. 2010 and the Decree of Board of SLRI, Ref. No. 8/2016, on “Appointment of Chief Executive Officer of Synchrotron Light Research Institute” issued on 1 June 2016, SLRI hereby announces more prevention measures as follows:

1. SLRI staff who have planned for trips and/or transit at risk areas or countries with COVID-19 infection in the period of 24 February - 24 April 2020 need to cancel or postpone all their trips. List of the areas and countries are as stated in the enclosure of this announcement.

2. The staff who have already received approval or allowance for trips to the above mentioned risk areas prior to this announcement issued need to cancel or postpone their trips to be after the above mentioned period of time.

In the event that cancellation or postponement cannot be made due to unavoidable reason, SLRI staff need to inform their superiors of reasons and necessities for further consideration. Those who receive approval for trips need to strictly perform in accordance with Article 3 mentioned below once returning to Thailand.

3. SLRI staff returning from or having transit at COVID-19 affected areas and/or countries within 24 April 2020 need to immediately contact Suranaree University of Technology Hospital or other officially registered medical institutes upon their return for disease screening and surveillance, also later inform their superiors of the results. In the event they develop suspected symptoms to COVID-19 infection, SLRI staff are urgently required to have medical treatment until fully recovered or have disease surveillance for at least 14 days from their arrival date to Thailand. In this case, the 14 days for disease surveillance of those who have official trips will not be considered as work absence cases while for those who have personal trips, the 14 days will be counted as taking leave days.

4. All invitation to guests from the overseas for any SLRI activities during 24 February-24 April 2020 need to be cancelled or postponed.

The staff are also requested to provide Suranaree University of Technology Hospital with any suspected infection case for the disease control at telephone number: 044-376555.
