Announcement of Synchrotron Light Research Institute (Public Organization) Guidelines for Prevention Measure and Surveillance of Coronavirus (2019-nCoV) (No.5)

Pursuant to the Announcement of Synchrotron Light Research Institute (Public Organization) on Guidelines for Prevention Measure and Surveillance of Coronavirus (2019-nCoV), dated 3 February 2020, the ongoing outbreak of COVID-19 still expands at a phenomenal rate with noticeable infections reported in many regions worldwide.

For further disease prevention and control of COVID-19, SLRI needs to announce additional measures and disease surveillances to prevent possible related effects on health of SLRI staff and their routine responsibilities. With reference to SLRI Regulation on "Working Hours and Official Holidays" B.E. 2010 and the Decree of Board of SLRI, Ref. No. 8/2016, "Appointment of Chief Executive Officer of Synchrotron Light Research Institute" issued on 1 June 2016, SLRI hereby announces additional prevention measures as follows:

1. SLRI staff are required to perform in response to these following necessary measures:

1.1 The official letter No. Nor Ror 0505/c113 dated 18 March 2020 issued by the Secretariat of the Prime Minister on " Conclusion of the COVID-19 Outbreak Emergency Operation Center's Meeting No. 1/2020", and the urgent prevention measures of COVID-19 emergency announced by Ministry of Public Health,

1.2 The Command of Nakhon Ratchasima Province No. 2478/2020 on "The Temporary Closures of Places",

SYNCHROTRON THAILAND CENTRAL LAB 1.3 The official letter No. Sor Tor 0410.7/c217 dated 21 March 2020, issued by National Communicable Disease Committee found under the Communicable Disease Act B.E. 2558, Department of Disease Control, Ministry of Public Health on "Request for Collaboration on Developing Local Operation Plan, Surveillance, and Prevention Measures against COVID-19 Outbreak Responding to the Case People Returning from Bangkok and Perimeter Provinces", and

1.4 The letter No. Mor Tor 0211.3/c1733 dated 22 March 2020 issued by Ministry of Interior on "Prevention and Risk Reduction Measures of Coronavirus (COVID-19) Outbreak in Villages and Communities".

2. All events requiring physical presence of user at the institute need to be refrained. However, conveying of samples from users to SLRI staff for further analysis, experiment, or test is still consecutively provided by performing mainly in accordance with Announcement of Synchrotron Light Research Institute (Public Organization) on Guidelines for Prevention Measure and Surveillance of Coronavirus (2019-nCoV) (No.4).

3. All people entering into the institute need to always wear surgical masks during their stay in the area of the institute.

In this regard, SLRI staff can acquire real-time surveillance of the outbreak from Department of Disease Control at website: https:// ddc.moph.go.th/viralpneumonia/ intro.php. The staff are requested to promptly inform Mr. Methee Sophon, Assistant Director (Administration), of any suspected infection case at Tel. 081-7183013 and at SLRI's official Line group for further disease control.
