Announcement of Synchrotron Light Research Institute (Public Organization)

Preventive Measures and Surveillances of Coronavirus (2019-nCoV)

(No.7)

Pursuant to the Announcement of Synchrotron Light Research Institute (Public Organization), dated 29 April 2020, on working at residences from 1 to 15 May 2020 for prevention of Coronavirus (COVID-19) outbreak, in order to sustain performing under related measures and prevent possible effects on health of SLRI colleagues in overall during returning to work performing at workplace, SLRI needs to implement additional preventive measures.

With reference to SLRI Regulation on "Working Hours and Official Holidays" B.E. 2010 and the Decree of Board of SLRI, Ref. No. 8/2016, on "Appointment of Chief Executive Officer of Synchrotron Light Research Institute" issued on 1 June 2016, SLRI hereby announces additional measures as follows:

- 1. SLRI shall be reopened from 16 May 2020 onwards with SLRI colleagues returning to perform works at workplace based on flexible and safe working procedure, and risk avoidance of COVID-19 outbreak. All performances need to be conformed to Announcements of SLRI on Preventive Measures and Surveillances of Coronavirus (2019-nCoV), Commands and Announcements of Nakhon Ratchasima Communicable Disease Committee, Commands and Announcements of Center for COVID-19 Situation Administration, and Commands of the Council of Ministers of Thailand.
- 2. The Announcement of Synchrotron Light Research Institute (Public Organization) on Guidelines for Prevention Measure and Surveillance of Coronavirus (2019-nCoV) (No.4) is cancelled.

3. SLRI maintains providing users with service on synchrotron light and

laboratory facility application as in normal situation under principle of practice that samples

for analysis, experiment, or test need to be sent from users to SLRI colleagues via post,

electronic mail, or other contact channels deemed appropriate. Similarly, results shall be

sent to users via appropriate stated channels.

4. All activities including conferences which require attendance of group of

participants need to be refrained. In the event that refrainment cannot be made, activities

need to be run based on social distancing measures or by using information and

communication technology instead.

5. SLRI colleagues are required to refrain or postpone their travel to or transit

at COVID-19-affected areas and/or countries according to the Announcements of Center for

COVID-19 Situation Administration until further notice.

6. All SLRI events requiring participants from the overseas need to be

refrained or postponed until further notice.
