Announcement of Synchrotron Light Research Institute (Public Organization)

Preventive Measures and Surveillances of Coronavirus (2019-nCoV)

(No.9)

Referring to SLRI Announcement on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.8) dated 27 May 2020 announcing on permission of physical presence of users at SLRI from 1 June 2020, in order to sustain performing under related measures and prevent possible effects on health of SLRI colleagues, under the SLRI Regulation on "Working Hours and Official Holidays" B.E. 2553 and the Decree of Board of SLRI, Ref. No. 7/2020, on "Appointment of Chief Executive Officer of Synchrotron Light Research Institute" dated 29 May 2020, SLRI hereby announces as follows:

- 1. The Announcement of Synchrotron Light Research Institute (Public Organization) on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.8) is announced to be repealed.
- 2. The Clause 2 in the Announcement of Synchrotron Light Research Institute (Public Organization) on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.5) stating that "all events requiring users' physical presences at the institute need to be refrained" is announced to be repealed and the following Clause shall be enforced instead:
- "Clause 2. SLRI services on synchrotron light and laboratory facility that requiring users' physical presences shall be provided to domestic users, except for those coming from COVID-19 affected areas and/or provinces as declared by the Nakhon Ratchasima Communicable Disease Committee.
