Announcement of Synchrotron Light Research Institute (Public Organization)

Preventive Measures and Surveillances of Coronavirus (2019-nCoV)

(No.10)

Pursuant to SLRI Announcement on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.9), dated 1 June 2020, on providing synchrotron light and laboratory facility services on site only to domestic users from non-COVID-19 affected areas or provinces from 1 June 2020 onwards, in order to sustain performing under related measures and prevent possible effects on health of SLRI colleagues working in the area, under SLRI Regulation on "Working Hours and Official Holidays" B.E. 2553 and the Decree of Board of SLRI, Ref. No. 7/2020, on "Appointment of Chief Executive Officer of Synchrotron Light Research Institute" issued on 1 June 2020, SLRI hereby announces as follows:

- 1. The Announcement of Synchrotron Light Research Institute (Public Organization) on Guidelines for Prevention Measure and Surveillance of Coronavirus (2019-nCoV) (No.3) is repealed.
- 2. A visit to SLRI by a person or a group of people with no more than 30 visitors is permitted. As for other cases due to some necessary reasons, they need to be raised for consideration of SLRI Chief Executive Officer on a case-by-case basis.
- 3. Clause 4 stated in the Announcement of Synchrotron Light Research Institute (Public Organization) on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.7) that "All activities requiring attendance of SLRI colleagues need to be refrained..." is repealed and the following Clause shall be enforced instead:
- "Clause 4. In the case of necessity, all activities requiring attendance of SLRI colleagues such as meetings need to be organized under social distancing measures or through information and communication technology."

- 4. Clause 5 stated in the Announcement of Synchrotron Light Research Institute (Public Organization) on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.7) that "SLRI colleagues are required to refrain or postpone their travel to or transit at..." is repealed and the following Clause shall be enforced instead:
- "Clause 5. SLRI colleagues who have planned for oversea trips are required to perform in accordance with the Guidelines or Announcements of Center for COVID-19 Situation Administration with no exception."
- 5. Clause 6 stated in the Announcement of Synchrotron Light Research Institute (Public Organization) on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.7) that "All SLRI events requiring participants from the overseas need to be refrained or postponed." is repealed and the following Clause shall be enforced instead:
- "Clause 6. Invitation to participants from overseas to participate in SLRI activity, meeting, seminar or other related events should be avoided."
- 6. SLRI colleagues are required to wear surgical masks whenever leaving their residences.
- 7. Fingerprint scan for clocking in and off is cancelled and SLRI ID card is to be used instead as well as for entering into and leaving SLRI buildings.
- 8. SLRI colleagues with at least one following symptom detected i.e. over 37.3°C fever, coughing, sneezing, sore throat, or runny nose are required to inform their superiors for leave permit and seek further medical attention.
 - 9. SLRI canteen service
 - 9.1 SLRI ID card scanners will be provided at the set points.
 - 9.2 Floor markings under social distancing measures will be provided.
 - 9.3 Distanced seats with barriers will be arranged.
 - 9.4 Canteen access is allowed for SLRI colleagues only.
- 9.5 Heads of departments are responsible of arranging appropriate time period for lunch break to avoid overcrowding.
