Announcement of Synchrotron Light Research Institute (Public Organization) Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.20)

To control the COVID-19 situation, prevent the disease widespread transmission, respond to the current preventive measures and surveillances of Coronavirus (2019-nCoV), and be consistent with current issued orders and announcements, SLRI therefore issues this announcement.

Pursuant to the Decree of Board of SLRI, Ref. No. 7/2020, on "Appointment of Director of Synchrotron Light Research Institute" issued on 29 May 2020, SLRI hereby issues the Announcement of Synchrotron Light Research Institute (Public Organization) on Preventive Measures and Surveillances of Coronavirus (2019-nCoV) (No.20) as follows:

1. SLRI colleagues are requested to refrain, postpone, or avoid traveling between provinces or to the maximum control and highly restricted areas or the maximum control areas as declared by Center for COVID-19 Situation Administration. In the case travelling to the stated areas is necessary for business, SLRI colleagues need to strictly abide by orders and announcements of Nakhon Ratchasima Communicable Disease Committee and destination provinces.

2. SLRI services on synchrotron light and laboratory facility application shall be provided as in normal situation with physical presence of only domestic users. In this regard, users coming from the maximum control and highly restricted, or the maximum control areas as declared by the Center for COVID-19 Situation Administration and having plans for overnight stay in Nakhon Ratchasima need to perform as follows:

2.1 inform communicable disease control officers of Suranaree University of Technology Hospital, Debaratana Nakhon Ratchasima Hospital, or other public hospitals within 12 hours after entering Nakhon Ratchasima area for further COVID-19 screening process

2.2 disclose the COVID-19 screen result as stated in Clause 2.1 to SLRI responsible colleagues and always complete the COVID-19 risk assessment form before entering SLRI area

These measures stated in Article 2 shall be exempted to users who have been vaccinated for 2 doses or have COVID-19 screen with RT-PCR method for less than 72 hours before entering Nakhon Ratchasima area and have the screen result disclosed to SLRI responsible colleagues.

3. In case of necessity, organizing of events or activities requiring physical attendance of SLRI colleagues are permitted based on safety measures. SLRI colleagues need to strictly abide by suggestions, orders, and announcements of Center for COVID-19 Situation Administration and Nakhon Ratchasima Communicable Disease Committee regarding the following cases:

3.1 visits by a person or a group of people from COVID-19 affected areas as declared by Center for COVID-19 Situation Administration to SLRI in Nakhon Ratchasima for business

3.2 invitation to participants from overseas to participate in SLRI activities, meetings, seminars, or other related events

3.3 organizing of events such as conferences requiring physical attendance of SLRI colleagues

4. SLRI canteen service shall be provided as in normal situation. In this regard, non SLRI colleagues need to complete the COVID-19 risk assessment form before entering the canteen area.

5. For risk reduction of COVID-19 infection, SLRI colleagues need to avoid travelling to places at risk or crowded communities and abide by preventive measures as follows:

5.1 always wear surgical masks and maintain at least 1-2 meters of distance in contacting with other people, and discard all used surgical masks in the provided containers or in closed plastic bags

5.2 always do handwashing with soap and water or 70% alcohol-based-

hand sanitizer

5.3 avoid sharing food containers, cutlery, and personal belongings with

other people

5.4 in case of having COVID-19 symptoms or suspect of infection,

contact a hospital for medical treatment and promptly inform a work superior
